

Bylaw Change proposals:

Bylaw change 1:

Purpose to add 2 VP's from the North and south to help manage the conference and better represent the conference.

E. GRADUATE EXECUTIVE VICE-PRESIDENT

The Graduate Executive Vice-President shall be a graduate and shall administer the intersectional selection according to PCCSC Intersectional Selection Procedures and enforce penalties when applicable. The Graduate Executive Vice-President shall review any conduct of participation issues, including individual or team, and submit a report of each incident to the Conference Commissioner and the Executive Committee. In the case of the Conference Commissioner being unable to fulfill his/her duties, the Graduate Executive Vice-President shall assume those duties until a replacement is elected.

E. GRADUATE EXECUTIVE VICE-PRESIDENTS

The Graduate Executive Vice-Presidents shall be a graduates and shall be one GEVP from the north and one from the south. The GEVPs shall administer the intersectional selection according to PCCSC Intersectional Selection Procedures and enforce penalties when applicable. The Graduate Executive Vice-Presidents shall review any conduct of participation issues, including individual or team, and submit a report of each incident to the Conference Commissioner and the Executive Committee. The GEVP's shall be part of the Executive Committee and be advisors to the conference commissioner. In the case of the Conference Commissioner being unable to fulfill his/her duties, the Graduate Executive Vice-President shall assume those duties until a replacement is elected.

Bylaw change 2:

ARTICLE VII - EXECUTIVE COMMITTEE

Foreword: The Executive Committee shall consist of representatives submitted by the area associations as outlined in the Standing Rules with the requirement that no less than two from each area are undergraduates of Regular Member colleges and not less than one from each area is a graduate. ~~The names of these representatives shall be submitted at the annual meeting~~ These officers shall be nominated by a nominating committee, formed by the conference commissioner, at the annual meeting the executive shall be elected, and they will serve a term of one year. All members of the Executive Committee shall have one vote in deciding the business of the Conference. It is the purpose of the Executive Committee to administer the general business of the Conference.

ARTICLE VII - EXECUTIVE COMMITTEE

Foreword: The Executive Committee shall consist of representatives submitted by the area associations as outlined in the Standing Rules with the requirement that no less than two from each area are undergraduates of Regular Member colleges and not less than one from each area is a graduate. The names of these representatives shall be submitted at the annual meeting, and they will serve a term of one year. All members of the Executive Committee shall have one vote in deciding the business of the Conference. It is the purpose of the Executive Committee to administer the general business of the Conference.

Bylaw change 3:

G. Executive Assistant shall be an elected position elected at the annual meeting. This position will conduct the day to day business of the PCCSC, which will include working with teams to update database, membership reports, and management of the conference. This position will report directly to the conference commissioner and this position will receive a stipend as approved in the PCCSC budget.

Standing Rule Changes:

Teams for 2017-2018: Give Executive Assistant ability to change this one for each year without approval.

1. For the 2014-2015 season the teams are divided as follows:
 1. North: CAL, CMA, CSUMB, SCU, STAN, UCD, UCSC
 2. South: ASU, SLO, CSUCI, CSULB, UCLA, UCI, UCSB, UCSD, USC, WEST

For the 2017-2018 season the teams are divided as follows:

3. North: CAL, CMA, CSUMB, SCU, STAN, UCD, UCSC, UNR,
4. South: ASU, SLO, CSUCI, CSULB, UCLA, UCI, UCSB, UCSD, USC, WEST

5. Charter Fees:

1. All charter fees (for boat use) must be paid to the chartering school or the borrowing school may not be scored in the regatta. Charter fees shall not exceed the following scale:
 1. Keelboats over 20' LOA: \$50.00 per day; sails included.
 2. Dinghies under 20' LOA: \$50.00 per day; sails and/or delivery not included.

5. Charter Fees:

1. All charter fees (for boat use) must be paid to the chartering school or the borrowing school may not be scored in the regatta. Charter fees shall not exceed the following scale:
 1. Keelboats over 16' LOA: \$100.00 per day; sails included.

2. Dinghies under 20' LOA: \$50.00 per day; sails and/or delivery not included.

17. PCCSC Coed Conference Championship – Mark Healy Trophy

1. Teams shall qualify for participation in Coed Conference Championship based on their combined score at the St. Francis Invite and the South Designate. A team's event score shall be their finishing place relative to other eligible teams. The University of Hawaii shall be exempt from this process provided they place in the top 10 school at the Fall Pacific Coast Championship and attend the St. Francis Invite or South Designate.

18. PCCSC Team Racing Championship – Carter Ford Trophy

1. If the event is held the same weekend as the Coed Conference Championship the fleet size shall be limited to seven eight (8) berths. The top seven finishers from the California State Team Racing Championship shall advance to the PCCSC Team Racing Championship. If the University of Hawaii chooses to sail the California State Team Racing Championship the top eight finishers shall advance to the PCCSC Team Racing Championship.

Not sure what to do here. What is our back up if championship can't be sailed? We do not have the CA state TR anymore. I would suggest we should create a TR league in the conference and lean back on the league results.

Team Race League: **To Start in Spring 2019**

Purpose of the league: To provide a structure and opportunity that fits a team's schedule. Providing more opportunity for teams, especially teams without coaches, will provide more opportunity for teams to sail against established teams with coaches and learn. The league would have a few events where the coaches, either team coaches or hired outside coaches would provide a debrief.

The key points of the league:

1. 2 tiers of events one with full umpires and has the top teams in the conference. Tier 2 would spread the top teams with developing teams in the league to create more learning opportunity, this tier would have regatta wide debriefs.
2. The Executive VP's will seed the league based on previous fleet and team race results and use the seeding to assign league events. The schedulers will work with teams to make sure the assigned regattas work with the school's academic schedule.
3. The league results would determine the top 8 teams to compete in the PCCSC Team Race Conference championship.

Team Race League Schedule:

Development Tier Regattas: These are the regattas where teams are put into regattas to spread the wealth and have coaching during a daily debrief. Umpires would be helpful here but not mandatory.

Gaicho Team Race: @ UCSB late Jan/Early Feb – 6 Team Regatta

Cal Team Race: @ Cal middle of February – 6 Team Regatta

Stanford Team Race: @ Stanford Middle of March – 6 Team Regatta

Championship Tier: These are seeded regattas that seed the top 4-6 Teams against each other. Umpires are mandatory. Entry Fee 100.00 per team to help with umpire costs.

McIntyre TR: @ Stanford Late February/Early March – 6 Team Regatta from PCCSC 2 Invites

South Team Race: @ south school- UCSB, USC, or SDYC First weekend of April – 8 Team Regatta

Very simple 1 point for first, 2 points for 2nd etc... low point scoring system.
